Device means:

- (a) an iOS® wireless handheld device manufactured by or on behalf of Apple® Inc, or other device or simulator authorised under Apple® Inc Software License Agreement to host iOS® Operating System, and not comprising more than one processor; or
- (b) a unique machine instance including physical computer or virtual machine running Barcode Essentials Console Application in either standalone configuration or in a browser environment; or (c) a Windows Mobile device running Symantec Barcoder application (any version) that synchronizes with the Solution;

Device License means a time-limited (expiring) or perpetual (non-expiring) license whether version locked or not, for a single Device that synchronizes with or performs wireless upload to the Solution; **License File** means a machine-readable file containing authorisation codes for one or more Device Licenses issued for a Server ID and provided to you by us in plain-text, encoded or encrypted format by any manner including but not limited to standalone file, email attachment or Internet data stream;

Redemption Code means a unique code provided to you by us for one-time use to permanently associate a License File with a single Server ID;

Server means a physical computer or virtual machine running a single and validly licensed copy of the operating system, compatible Symantec Management Platform version and Solution software for which the License File was designed, and having a unique Server ID;

Server ID means a unique identity string reported by the Solution for a Server;

Solution means Barcode Essentials Licensing Solution or Barcode Essentials Solution, including associated software components, media, printed materials and "online" or electronic documentation and additionally all versions of the Solution made available for download from the Website or provided to you as part of Support;

Support means a method for accessing support benefits, being one of: (a) online help desk tickets via http://support.barcodeessentials.com; (b) email requests to support@barcodeessentials.com; (c) other support channels as indicated on the Website;

Website means www.barcodeessentials.com and all sub-domains of barcodeessentials.com; **You** and **Your** refers (as applicable): (a) if you are a person, to you in your capacity as buyer of the License File; or (b) if you are entering this EULA in your capacity as the duly authorised representative of a company or other entity who is buying the License File, to the company or other entity that you represent.

1.2 Interpretations

2. GRANT OF LICENSE.

2.1 Terms of Use
